Photo ID Now Required at Elections....



These are acceptable for voting purposes, and can be unexpired or expired after the date of the most recent general election (currently, the November 4, 2014 election):

A Wisconsin DOT-issued driver license, even if driving privileges are revoked or suspended

A Wisconsin DOT-issued identification card

Military ID card issued by a U.S. uniformed service

A U.S. passport

These photo IDs are also acceptable for voting purposes, but must be unexpired:

A certificate of naturalization that was issued not earlier than two years before the date of an election at which it is presented

A driving receipt issued by Wisconsin DOT (valid for 45 days)

An identification card receipt issued by Wisconsin DOT (valid for 45 days)

An identification card issued by a federally recognized Indian tribe in Wisconsin

A photo identification card issued by a Wisconsin accredited university or college that contains date of issuance, signature of student, and an expiration date no later than two years after date of issuance. **Also, the university or college ID must be accompanied by a separate document that proves enrollment.**

LUDINGTON PERMITS/INSPECTIONS

Permits and inspections may be required for construction of a building or a new residence, when performing electrical work, construction of storm water and erosion control management systems, and new driveways. These permits are issued directly through the Town of Ludington, not through Eau Claire County. For building or electrical permits, contact our Inspector – Fred Hankel at 715-577-7983. For storm water/erosion control or driveway permits, contact Chairman Randy Horlacher at 715-877-2578. You can also come to a Town Board meeting if you have questions – meetings are held at 7:00 p.m. on the 2nd Thursday of each month at the Ludington Town Hall located at E19980, County Road D, Fall Creek.

Burning Permits are also required by the State of Wisconsin. See “Important Information” on the next page for details.

Dog Licensing &
Rabies Vaccination Clinic
Ludington Town Shop
- February 27, 2016 -**

As a benefit for Ludington Town residents, the Town of Ludington will be hosting a Licensing and Rabies Vaccination Clinic on **February 27th** from **10:00 a.m. – 12:00 p.m.** at the Ludington Town Shop. The cost per dog is \$14 for the rabies shot, plus \$6 for the license if your dog is spayed/neutered or \$16 if not.

The State of Wisconsin mandates you license your dog(s). Per State Statute 174.05 Dog License Tax. (1): REQUIREMENT. Except as provided in s. 174.054, the owner of a dog more than 5 months of age on January 1 of any year, or 5 months of age within the license year, shall annually, or on or before the dog becomes 5 months of age, pay the license tax and obtain a license.

**Please have your dog on a leash or in a pet carrier
while at the clinic – thank you.**

NOTE: Failure to comply with the mandate to license your dog(s) on time will result in additional fees and potential fines, something no one wants, including the Ludington Board. Late fees/fines are assessed beginning April 1st. Please make everything easy and license your dog(s). Please let us know if you have any questions.

Driveway Permits – if your driveway will be on a Town Road call Randy at 877-2578 for a permit; if on a County Road, contact the County directly

Fire/Burning Permits – to report a fire call 911. Steps for Responsible Burning:

- * Obtain an annual permit from The Woodland, a local Ranger Station, or by dialing 1-888-947-2876 to have permit mailed or instantly emailed.
- * On the day of the burn, check after 11:00 a.m. on the internet or over the phone: dnr.wi.gov/wisburn and click on county OR 1-888-947-2876 and enter our County Code (18).
- * Follow the rules for the day, have tools and water, and make certain your fire is completely out before leaving.
