Local Girl's Gold Award and Emergency Siren

Lauren Lea accomplished a major goal in 2016, with Ludington and Bridge Creek residents being major benefactors. Lauren is a local Girl Scout who set out to achieve the highest award a Girl Scout can – the Gold Award. This requires that the Girl Scout must lead a project that will have a lasting impact on her community. Lauren chose to have an Emergency Weather Siren installed on Lake Eau Claire. This was a very ambitious project. The project was originally projected to cost \$25,000. Lauren worked closely with the Town of Ludington, the Lake Eau Claire Rehabilitation District, and the Lake Eau Claire Association. Raising \$25,000 was not going to be an easy task – she spent countless hours putting together packets for a mass mailing, writing speeches, presenting, writing articles, writing grants, sending emails, and talking to numerous people about the project. Well in 6 months, Lauren raised \$24,000+. This money paid for the siren in full, which does include monies for on-going maintenance. Lauren's family fully supported her efforts on this project plus contributed \$1,000 for materials and expenses during her research, fundraising, etc.

The Siren was installed on Lake Eau Claire on December 5^{th} and 6^{th} and is up and running. The siren is connected to the Eau Claire county-wide emergency management system and is triggered and tested with the other sirens in the county. The first test was on January 2^{nd} .

Congratulations to Lauren on doing a fantastic job in accomplishing her goal. We commend her. We, the residents of Ludington, want to thank Lauren for bringing this siren to our community! It is now a safer place to live.







<u>Ludington</u> Permits/Inspections

Permits and inspections may be required for construction of a building or a new residence, when performing electrical work, construction of storm water and erosion control management systems, and new driveways. These permits are issued directly through the Town of Ludington, not through Eau Claire County. For building or electrical permits, contact our Inspector - Fred Hankel at 715-577-7983. For storm water/ erosion control or driveway permits, contact Chairman Randy Horlacher at 715-877-2578. You can also come to a Town Board meeting if you have questions - meetings are held at 7:00 p.m. on the 2nd Thursday of each month at the Ludington Town Hall located at E19980, County Road D, Fall Creek.

Burning Permits are also required by the State of Wisconsin. See "Important Information" on the "SAVE THIS PAGE".

If you are interested in being an Election Inspector, please contact Colleen at 715-563-5472. The State of Wisconsin mandates you license your dog(s). Per State Statute 174.05 Dog License Tax. (1): REQUIREMENT. Except as provided in s. 174.054, the owner of a dog more than 5 months of age on January 1 of any year, or 5 months of age within the license year, shall annually, or on or before the dog becomes 5 months of age, pay the license tax and obtain a license.

To license your dog in Ludington, you can do so at the annual Ludington Rabies Clinic generally held in February (this year's date is February 11th from 10a.m. – 12:00 a.m. at the Town Shop), or you can complete the form available at the Town Hall/Shop and send it along with a copy of current rabies vaccination and payment to the Ludington Treasurer.

NOTE: Failure to comply with the mandate to license your dog(s) on time will result in additional fees and potential fines, something no one wants, including the Ludington Board. Late fees/fines are assessed beginning April 1st. Please make everything easy and license your dog(s).

Fire/Burning Permits – to report a fire call 911. Steps for Responsible Burning:

- * Obtain an annual permit from The Woodland, a local Ranger Station, or by dialing 1-888-947-2876 to have permit mailed or instantly emailed.
- * On the day of the burn, check after 11:00 a.m. on the internet or over the phone: dnr.wi.gov/wisburn and click on county OR 1-888-947-2876 and enter our County Code (18).
- * Follow the rules for the day, have tools and water, and make certain your fire is completely out before leaving.
